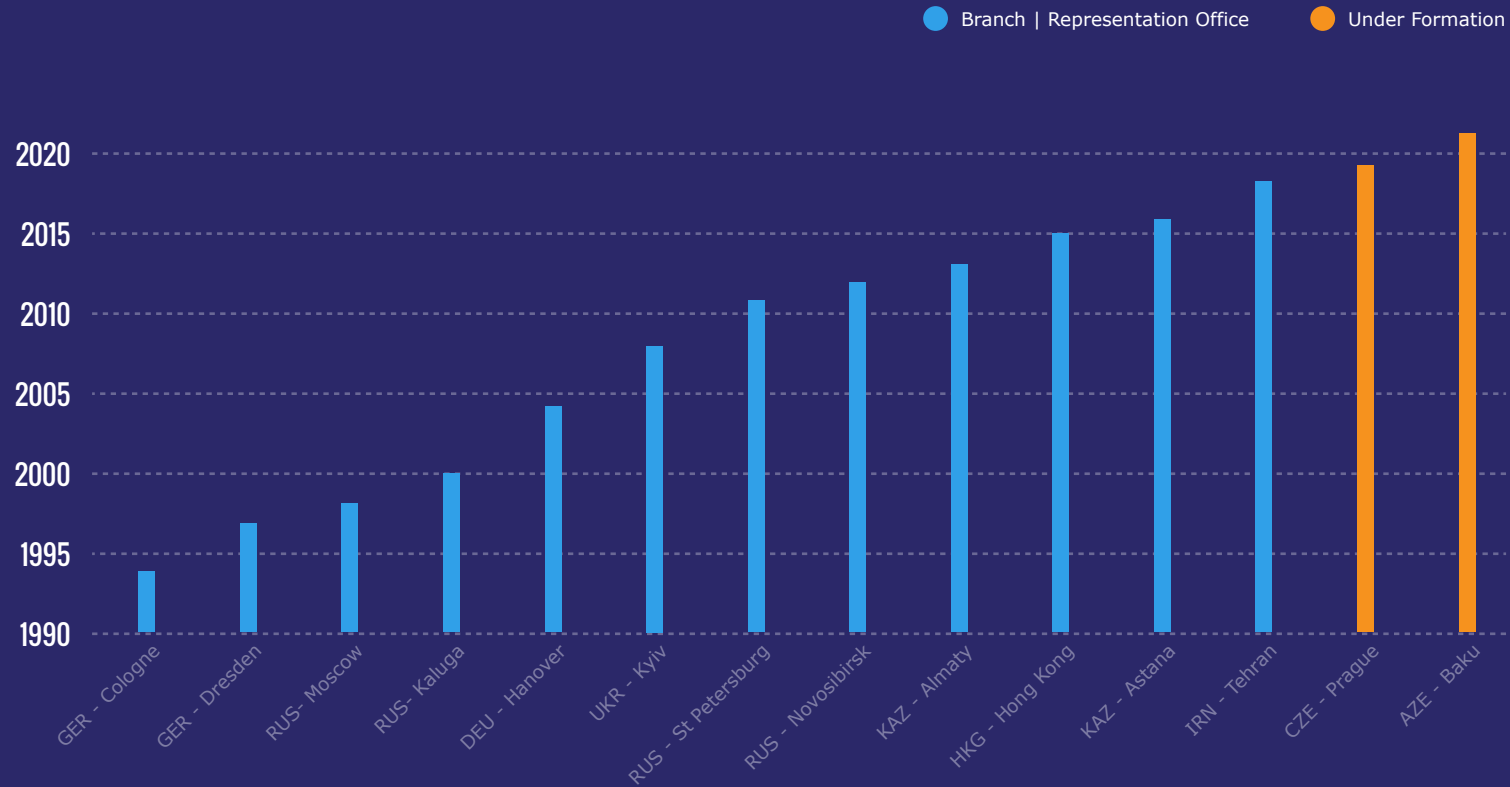

Today INTERPONT GROUP comprises more than 15 companies tailored to customer needs, service demands and country specifics.

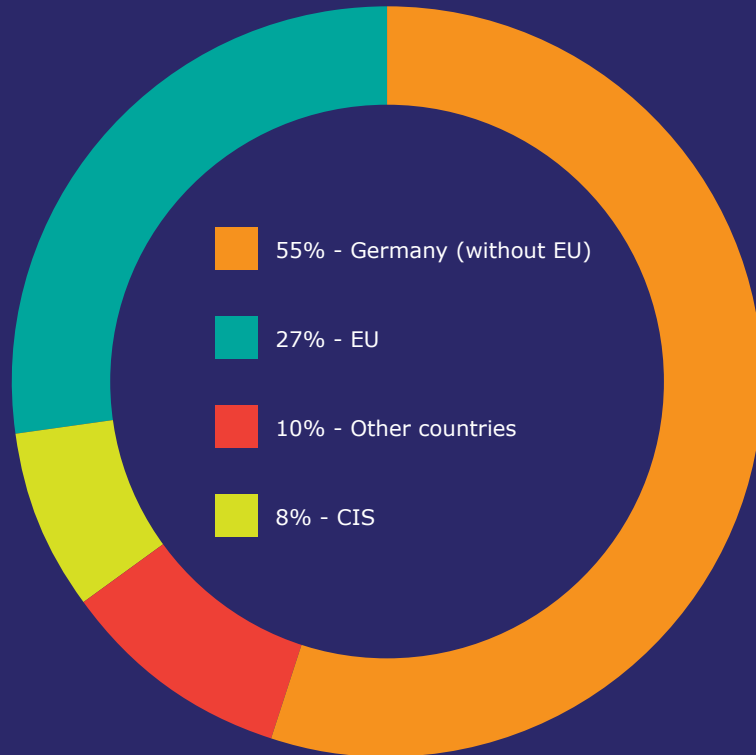
Two independent companies were founded in 2009 to perform audit from the certified experts in the following countries:

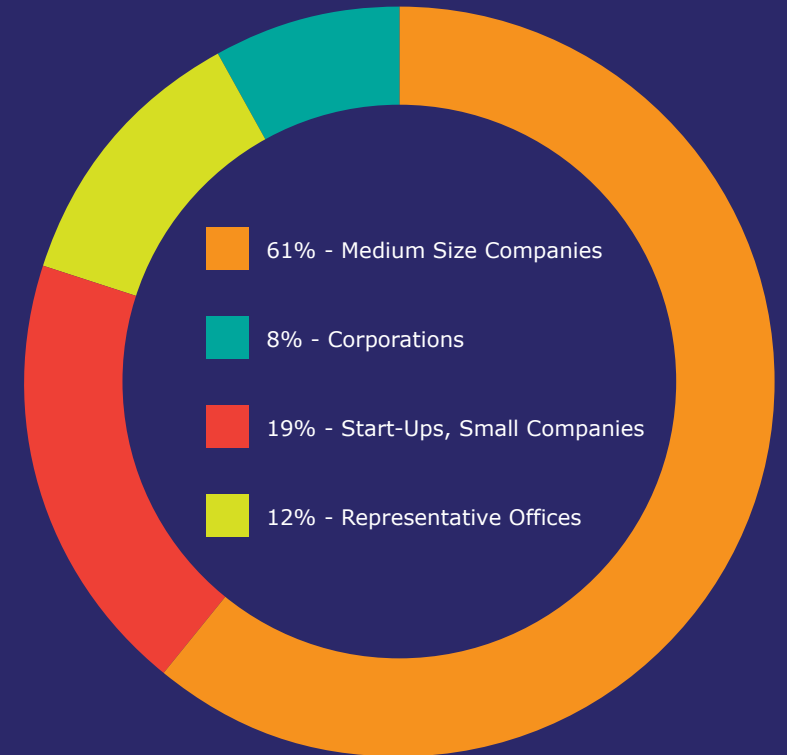
